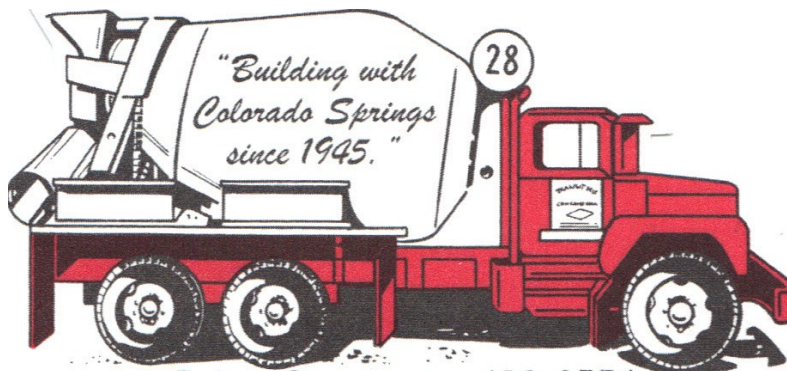

## **NATIONAL CORVETTE MUSEUM**

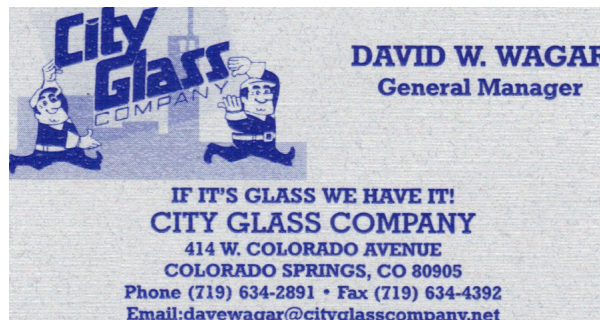
